The allowances are given as a guide to what local customs authorities will allow into each country, free of duty. Every effort has been made to ensure that the allowances shown are correct, but these are subject to alteration without notice.

1 Allowances are for passengers other than those travelling between mainland China, Hong Kong and Macau. **2** Non-residents are allowed 400 local brand cigarettes and 400 foreign brand cigarettes. Residents and foreigners residing in Japan are allowed 200 local brand cigarettes and 200 foreign brand cigarettes. **3** Inflight sales are not available on flights between Singapore and East & West Malaysia, between destinations within Australia, Africa, Middle East, New Zealand and intra-Europe (except Milan-Barcelona v). **4** Wines, spirits and other alcoholic beverages brought in without prior permission will be confiscated. **5** Duty-free cigarettes are NOT allowed into Singapore. However, passengers travelling on international flights on transit in Singapore are allowed to purchase duty-free cigarettes. Each traveller above 18 years of age who has spent more than 48 hours outside of Singapore immediately before his/her arrival and not arriving from Malaysia is allowed duty-free allowance in the quantities stated above. **6** A returning US resident is entitled to bring US\$800 worth of duty-free merchandise (inclusive of tobacco and liquor) back into the US. **7** Wines/spirits and cigarettes can only be imported by travellers at least 17 years old. **8** Passengers must be 18 years old and above. If passenger holds a Hong Kong Identity Card, he must have spent 24 hours or longer outside of Hong Kong. **9** Duty-free allowances for each inbound traveller to Taiwan is NT\$20,000 for total baggage value of duty exemption. Minors under 20 years old are not allowed to carry alcoholic beverages and cigarettes, cigars or tobacco. **10** When arriving in the UK from an EU country, most goods are permitted with unlimited amounts, with no restrictions for excise goods such as alcohol and tobacco when personally carried for own use or as gifts, and the duty and tax paid in the EU purchase. Purchaser must be over 17 years old. **11** In New Zealand, sale of alcoholic beverages and tobacco products to persons under 18 years old is restricted. **12** If purchased at Duty Free on arrival, a limit of US\$500 in expenditure with 12 bottles of liquor per passenger is imposed.

Liquids, Aerosols and Gels Restriction for Transit/Transfer passengers:

- Duty-free items can be purchased in a sterile area (inflight sales included)
- Duty-free bags must be sealed and accompanied by proof of purchase
- Duty-free items bought at transit stations will not be permitted through the screening point
